

## Guaranteed/Charity Place:

For a charity place at the Great North Run 2024 you pledge to raise a minimum of £275 (excluding Gift Aid) in sponsorship money for St Mary's Hospice, which should be received by SMH within one month of the Great North Run. All funds raised through the Great North Run must be payable to St Mary's Hospice in £ sterling. The objective is to raise as much sponsorship as possible.

## All participants:

- You confirm that you are medically fit and that you participate in the event at your own risk. St Mary's Hospice will not be held responsible for injury or illness resulting from your participation
- You understand that it is your responsibility to read any Terms and Conditions issued by the race organisers and to comply with these
- The minimum age to join St Mary's Hospice at the Great North Run 2024 is 17. You confirm you will be the minimum age on race day
- You acknowledge that St Mary's Hospice may incur costs as a result of you joining Team St Mary's (For example cost of producing and sending fundraising packs, technical kits, etc.) for this challenge. The objective is to raise as much sponsorship as possible
- Half of your fundraising total (£137.50.00) is due 12 weeks prior (21st June 2024) pre-race day, as a charity we have paid the upfront cost for your place, therefore if you cancel your place for any reason (including illness or injury) then you pledge to pay St Mary's Hospice 50% of your minimum sponsorship (£137.50). As a charity we will do everything to re allocate your place, but if we cannot do so then you as an individual would be required to make a minimum payment of £137.50 to SMH.
- You have provided St Mary's Hospice information about you and consent to St Mary's Hospice using this data. You understand that it will be necessary for St Mary's Hospice to share your data with the race organisers in order to participate in the Great North Run 2024
- St Mary's Hospice do not sell or swap your details with any third parties.
- We will keep your details on our database so we can provide you with the best possible support every time you contact us.
